- We require an adoption fee of \$85.00 for dogs and \$60.00 for cats, to help defray our expenses for food and veterinary care. The adoption fee is not refundable under any circumstances. For dogs, the \$85 fee includes collar with ID tag, worming, physical exam, spay/neuter, and 1-hour private obedience training class. BMHS pays for rabies and first shots on puppies and dogs. Adopter is responsible for any subsequent inoculations. The \$60 fee for cats includes all of the above (for dogs) with the exception of obedience training.
- You understand that this animal was previously unwanted or lost and may have been rescued from a dangerous, unhealthy and/or cruel situation and may have been exposed to disease. This could have long-lasting effects on the animal. You agree that we are making no representations or warranties about the condition, health, personality or temperament of the animal.
- You agree to provide the animal with fresh water, wholesome food, suitable shelter and exercise. You agree not to keep the animal chained or confined for extended periods of time. You agree never to use the animal for fighting.
- You agree to provide routine veterinary care and vaccinations for the animal and in case of illness, you agree to seek prompt veterinary care by a licensed veterinarian.
- You agree never to abuse, abandon or dispose of the animal in any way and to notify us if you no longer want to, or no longer can keep the animal, so that we can take the animal back to arrange for another adoption.
- BMHS is not liable for any claims, legal actions, losses, injuries, damages, costs, expenses or liabilities whatsoever with your adoption or ownership of the animal.
- Adopter agrees to save and hold harmless BMHS, its employees, agents, members or representatives, from any claims for damages resulting from adoption of this animal.
- This Agreement is the entire Agreement between you and us, and supersedes any Agreement. No modification of this Agreement will be valid unless in writing duly signed by both you and us. This Agreement is binding upon your and our heirs, assigns, successors, personal representatives and executors.
